### Stronger Together



the cliche, "a picture is worth a thousand words." The quick words that come to mind: wellness, community, inspiration, professionalism, advocacy, beauty, altruism, and fun, just to name a few.

It's sunrise on the second day of the American Dental Association Dentist and Student Lobby Day in our nation's capital. Over 1,200 ADA members and dental students representing ASDA have taken time out of their busy schedules to travel to Washington, D.C., for three days to participate in Lobby Day. This includes seven doctors from Oregon and 11 students from OHSU School of Dentistry. ADA President Elect Dr. Brett Kessler, who has long been an outspoken advocate for wellness, has invited anyone who is interested to join him for a "no drop" run to the Lincoln Memorial and, specifically, the step that includes an engraving marking the spot where Dr. Martin Luther King Jr. gave his "I Have a Dream" speech in 1963.

Over 100 dentists and students (including me!) meet at 6:00 a.m. for the 2+ mile jaunt to the Memorial. After some time appreciating a beautiful sunrise, Dr. Kessler speaks from near the MLK step, asking us each to reflect on the sacrifices that Dr. King made, and for each of us to find



inspiration in some manner from those sacrifices others have made for us.

Overlooking several of the other memorials along the National Mall, I am sure I was not the only one feeling inspired by the stories that each of these memorials represents: the soldiers represented in the Korean War Memorial, the obelisk memorial to the humble Father of our Country George Washington, or the noble statue of Abraham Lincoln behind us, a symbol of his diplomacy and wisdom.

It is highly unlikely that any of us will have such memorials on the National Mall commemorating us; however, Lobby Day brought together 1,200 dental professionals in their own way making time to be part of a community to strengthen our profession – 1,200 people who are inspired to be together to advocate for student debt assistance during residency programs and for faculty at dental schools. Speaking with staff of representatives and senators (and sometimes the legislators themselves) about funding for oral health care workforce issues. Urging members of Congress to extend federal protections against dental insurance companies setting fees for non-covered services.

I know that many dentists don't believe in the value of the ADA, yet I ask myself – and all of you – a question. What can a dentist who is not a member do to help with any of these issues? I've never seen legislation introduced by an individual that addresses any of these issues. The reality is that legislation in Salem and Washington, D.C., needs the lobbying power and knowledge of organized dentistry – of the ADA and the ODA – to be passed.

The 100+ professionals in this photo are having fun while making a sacrifice to help our profession.

You don't need to travel to Washington, D.C., and wake up at 6:00 a.m. to go for a run to hear an inspirational message. But supporting and encouraging those who do is a great way to help our profession. Your membership does make a difference by supporting those professionals and, in turn, supporting your profession, your practice, and your patients. We are stronger together.

### Advocating for the Future: Reflections on ADA Lobby Day 2024

ADA LOBBY DAY 2024 IN WASHINGTON, D.C., served as a pivotal moment for dentists and dental students alike, offering a platform to advocate for our rights and engage with policymakers on critical issues. Throughout the event, we embarked on a journey of empowerment, solidarity, and advocacy, driven by a shared commitment to shape the future of our profession.

At the outset of the event, we were able to participate in workshops and training sessions designed to equip us with the skills to effectively communicate our stories to senators and representatives. The pinnacle of ADA Lobby Day 2024 was the opportunity to lobby at the Capitol, engaging directly with state representatives and senators. As ODA members, we seized the chance to advocate for our profession, sharing our stories and pressing for legislative action on the REDI Act, the DOCA, and workforce shortages. The REDI Act in particular hit home for many of the students. Since many of us are planning or going into a residency, the REDI Act would help relieve some of the financial burden of dental school



and residency by deferring the interest rates of our student loans. In these interactions, my peers and I were able to share our personal stories. Some of us work part time to offset the burden of student loans. Others want to give back to their communities by providing specialty care in rural areas. I was touched to hear my peers' stories and felt honored that I got to advocate alongside them. Each student played a pivotal role in shaping the future of our profession, advocating for policies that promote equity, access, and excellence in dentistry.

As the event drew to a close, we departed with a renewed sense of purpose and determination. In lobbying our representatives, we had not only made our voices heard but also laid the groundwork for future advocacy efforts. Empowered by our experiences, we returned to Oregon with a commitment to continue advocating for our profession as students.

In conclusion, ADA Lobby Day 2024 was a testament to the power of student activism and advocacy in shaping the future of dental care. Through storytelling, legislative engagement, and community-building, we were able to leverage our collective voice to champion the interests of dental students and dentists and advance policies that promote equity, access, and excellence in the dental field. As we look to the future, we carry forward the lessons we learned and the relationships forged, knowing that together, we have the power to create a brighter, more inclusive future for all, advocating not just for ourselves, but for the future of our profession.

FEDERAL LEGISLATION

ODA members recently traveled to Washington, D.C., to advocate for three bills identified as priorities for dentists

WHILE THE ODA IS FOCUSED ON **SUPPORTING** legislation improving access to care and streamlining the activities of dental offices in Oregon, the ADA is actively advocating for policies and legislation at the federal level. Eighteen ODA members and Oregon dental students recently traveled to Washington, D.C., to participate in the ADA Dentist and Student Lobby Day, where they met with members of Congress and their staff to urge them to support bills that have been identified as priorities by the ADA. Below you will find summaries of the three bills that the ADA is prioritizing this year on behalf of dentists and patients.

#### **Dental Workforce** S. 2891, Action for Dental Health Act

One of the ADA's top priorities in the Senate is S. 2891, the Action

for Dental Health Act. This concept, which has already seen a companion bill, HR. 3843, pass out of the House of Representatives, would help address critical gaps in the oral health workforce.

As many dentists in Oregon know, the dental hygienist and dental assistant workforce shortage has been extremely challenging since the pandemic. Nearly 87% of dentists recently told the ADA that recruiting for these positions is extremely challenging, a trend that aligns with what the ODA has heard from its own members, despite many dentists offering new incentives to prospective dental team members. These workforce challenges can result in significant obstacles for access to care, as a lack of dental team members limits the number of patients that dentists can see.

S. 2891 would reauthorize and extend funding for Action for Dental Health through fiscal year 2026. Action for Dental Health has already supported many state-based efforts to reduce dental disease through oral education and expanding the oral health workforce and placing providers in areas with the greatest need, among other important initiatives. S. 2891 would support workforce training and oral health programs with the goal of delivering care to those who need it most, in addition to strengthening and expanding the public/private safety net and bringing dental health education and disease prevention into underserved communities.


The ODA has worked in recent Oregon legislative sessions to try to pass similar legislation that would help address workforce shortages across the state, and anticipates supporting similar legislation going into the 2025 long session.

#### Student Loans and Postgraduate Educational Debt

H.R. 1202/S. 704 | H.R. 7814/S. 2172

Two of the top policy priorities for the ADA this year are H.R. 1202/S. 704, the Resident Education Deferred Interest Act (REDI Act) and H.R. 7814/S. 2172, the Dental Loan Repayment Assistance Act. Both bills seek to establish fair and reasonable methods to offset unprecedented levels of educational debt for dental and medical residents and dental school faculty.

Sixty-five percent of dental school graduates who have educational

debt will start their careers with more than \$300,000 in student loans. Many of these loans have interest rates as high as 9.5% or 10.5%, and payments can last anywhere between 10 and 30 years, depending on the repayment plan.

Educational debt disproportionately impacts new dentists pursuing a low- or non-paying dental or medical residency program, and established dentists hoping to educate students, conduct research, and deliver oral health services through dental school practices and clinics. Even if borrowers are able to have their payments temporarily halted or reduced, the interest accrues regardless. This is essentially an interest penalty just for pursuing a low- or non-paying medical or dental residency or pursuing an academic career.

The REDI Act would allow medical and dental students to automatically defer payments on their federal student loans until after their medical or dental residency is completed, in addition to suspending the accrual of interest on federal student loans during the residency period. The Dental Loan Repayment Assistance Act allows full-time faculty members participating in the Dental Faculty Loan Repayment Program to exclude federal loan repayment assistance from their taxable income.

#### Dental and Optometric Care (DOC) Access Act S. 1424/H.R. 1385

Oregon is one of 42 states that have already passed laws limiting interference with the dentist-patient relationship when a dentist delivers services not covered by insurers. However, because many dental plans are federally regulated, some

large insurers are claiming that they are exempt from having to follow state laws.

This loophole is why the ADA is prioritizing S. 1424/H.R. 1385, the Dental and Optometric Care Access Act (DOC Access Act) as one of its top issues at the federal level. The bill would prohibit dental and vision plans from setting the fees network that doctors may charge for services not covered by the insurers.

It would also establish some "rules of the road" for provider network participation:

 Prevents plans from establishing nominal payments for otherwise non-covered services in an effort to have such services considered covered inappropriately.

- Limits network agreements to two years for each contract extension unless the doctor agrees to accept a longer contract extension.
- Preserves doctors' freedom of choice in laboratories.

Non-covered services provisions in dental and vision plans disadvantage enrollees, doctors, and the public at large because they interfere with the patient-doctor relationship, skew the pricing charged to non-subscribers, and encourage the consolidation of the dental and vision insurance industries, resulting in overall higher premiums. This bill, developed at the request of dentists, seeks to address those negative impacts on patients and providers.



#### Federal Lobbying Accomplishments

The first half of the 118th Congress ended in 2023 with some notable accomplishments helping the profession even during the divided partisan times in Washington, D.C., during which only 29 bills passed both chambers of Congress and were signed into law.

#### Workforce

- Advocated for the U.S. House of Representatives to pass the Lower Costs, More Transparency Act, which would extend programs
  that are integral to bolstering the dental and medical workforce and increase access to health care, particularly in underserved
  communities.
- Worked to advance the Bipartisan Primary Care and Health Workforce Act out of the Senate Health, Education, Labor and Pensions Committee. The bill includes funding extensions for the State Oral Health Workforce Improvement Grant Program (Action for Dental Health), Community Health Center Fund, the National Health Service Corps, and the Teaching Health Center Graduate Medical Education Program.
- Advanced the Action for Dental Health Act (ADH) out of the House Energy and Commerce Committee by a vote of 50-0. The bipartisan reauthorization of the ADH program through 2028 would direct funding to state and local organizations through a Health Resources and Services Administration oral health workforce grant program. The bill has also been introduced in the Senate.

#### **Dental Insurance Reform**

- Continued efforts to improve the dental insurance landscape by getting the Dental and Optometric Care Access Act reintroduced in
  the Senate and House. The bipartisan federal legislation would prohibit dental and vision plans from setting the fees network doctors
  may charge for services not covered by insurers.
- Began collaboration to engage with elected leaders to reconsider preemption of current dental insurance laws after recent Supreme
  Court Decision that ruled the Employee Retirement Income Security (ERISA) insurance plans can be regulated. The ADA is positioned to
  impact possible upcoming legal cases in the area of ERISA case law apply to dental insurance, limiting federal preemption by insurers.

#### **Access to Care**

- Testified at the very first hearing of the Subcommittee on Health Care of the U.S. Senate Finance Committee hearing, titled "An Oral Health Crisis: Identifying and Addressing Health Disparities."
- Advocated on payments for hospital outpatient (OPPS) and ambulatory surgical centers (ASC) to Centers for Medicare & Medicaid Services (CMS) by supporting higher reimbursement rates for the facilities and eliminating the proposed Medicare pay rate cuts associated with G0330 code.
- Sent comments to CMS in response to a proposed rule on Medicare Advantage pertaining to data collection, transparency
  in marketing, and quality improvement. CMS noted they are prioritizing MA dental benefits by requiring "detailed reporting
  on supplemental benefit expenditures by plans in the medical loss ratio report as well as looking cracking down on predatory
  advertising of supplemental MA benefits."
- Received agreement from CMS that clinical evidence supports dental services being paid for when they are linked and related to
  the success of other covered services like treatment for head and neck cancers through treatment of chemotherapy, chimeric
  antigen receptor T-cell therapy, and the use of high-dose bone modifying agents, or antiresorptive therapy, as well as for medically
  necessary diagnostic and treatment services to eliminate oral/dental infections prior to or contemporaneously with such treatments.
- Partnered with the American Academy of Pediatric Dentistry to successfully call for the Health Resources and Services Administration to retain a national performance measure for oral health in Title V programs, rather than transitioning to a state measure.

### ODC New Dentist Award -Adam Fox, DMD

**ODC AWARD** WINNERS

#### THE YOUNGEST OF SIX CHILDREN

in a military family, Dr. Adam Fox was born in California and lived in New Jersey, Arkansas, and overseas before moving to the West Coast. His wife grew up in Medford, and they moved back to her hometown, where they are raising their five children and he owns Fox Dental.

Dr. Fox originally graduated with a business degree and worked at Lithia Motors and Harry & David before going to dental school. His interest in dentistry is rooted in a childhood incident in which he face-planted on a tile floor and chipped his front teeth. Over the years, they chipped repeatedly and led to a root canal and "funny looking teeth," he said.

Years later, while on a service mission with a dentist who crowned his front teeth, Dr. Fox was struck by the impact a dentist can have on people.

"I think about Dr. Irwin all the time. It was just so nice to be able to smile and not want to hide my front teeth and to have that confidence," he said, noting that Dr. Irwin's generosity impacted the way he practices. "A little kindness can go a long way."

He graduated from the Oregon Health & Science University School of Dentistry in 2015 and chose to do an additional year of training at Idaho State University's Advanced Dental Education Program. He began practicing in 2016 and quickly witnessed his own impact on a patient.

"There was a woman who had been in a car accident and lost many teeth, and she had just gotten her implants. She cried and was so happy, it made my day," he said.

Dr. Fox has been consistently involved with the Southern Oregon Dental Society. He started his term as vice president in 2019 and became president in 2020, a role he continues to fill today. Among other benefits, the component offers social connections, high-quality continuing education, and interesting speakers who help raise the standard of care, he said.

"I think it's so important to make sure you have at least some voice on the national level and locally," Dr. Fox added. "Cameron [Cutler] is a great executive director who makes it easier for the officers. Without Cameron, we wouldn't have a club."



As a member of Rogue Excellence Dental Club's Advisory Board, Dr. Fox has provided more than \$40,000 in free dental treatment to veterans through the Freedom Day USA program. Although he's no longer involved with the program, he still partners with the VA to take on some cases.

Dr. Fox's peers commented that he "models that it's okay to have hard days and makes talking about it or seeking support approachable." Dr. Fox responded by explaining, "Dentistry is really hard. I think it's important that we've got people we feel comfortable with and can share our feelings with. Rogue Excellence does that for me."

He advised other new dentists to join a study club like Rogue Excellence and participate in CE courses early in their careers. Study clubs provide opportunities to meet like-minded others who are intelligent and have experience and expertise to share.

Dr. Fox added that he is humbled to receive the ODC New Dentist Award given that there are so many other talented new dentists practicing across the state. "I think of myself as the most mediocre dentist in town. and this award inspires me to elevate my level. It feels like a challenge to be better."

# Tom Tucker Humanitarian Award – Tom Holt, DDS

AFTER GRADUATING FROM THE CREIGHTON UNIVERSITY School of Dentistry in 1999, Dr. Tom Holt moved to Coos Bay and took over the well-respected practice of Dr. John Meunchrath. Dr. Holt immediately became a leader in the local dental community, serving terms as president, secretary/treasurer, and professional relations officer for the Southwest Oregon Dental Society. He also served as a trustee of the Oregon Dental Association and is a member of the Academy of General Dentistry and the American Dental Association.

Involvement in organized dentistry is important to him because, in order for the profession to maintain its legitimacy and autonomy and to deliver on its duty to provide oral health care to the public, dentists have to actively and continuously promote high standards among their peers, he said.

"We have to stay ahead of the curve of the challenges that are going to face our industry and ourselves as individuals so we can face those challenges without getting diverted from our mission and from our ideals," Dr. Holt said.

The camaraderie provided by organized dentistry also is essential. "The work we do is challenging and can be isolating. Dentists can't really talk to anybody else about where we feel vulnerable in our work except for with other people who share that vulnerability," he noted.

Dr. Holt has been involved in community programs such as Ready to Smile and Neighborhood Dentist, which foster partnerships between dental professionals, schools, nonprofits, and local government agencies to provide increased care for children throughout Coos County.



"In order to really connect with our patients and our community for oral health care, we really have to connect with the bigger picture of our patients' lives. Our patients have to know who we are, we have to know who our patients are, and these programs help make those connections," he said.

Dr. Tom Holt Family Dentistry was instrumental in bringing back the "I AM..." photo shoot and exhibit, which is a platform for students and teachers at The Lighthouse School,

Sunset Middle School and Marshfield High School to talk about diversity and celebrate their identity. Held at the Coos Art Museum, the I AM... exhibit drew nearly 700 participants, their families and friends.

"Community projects like the I AM... campaign fill my cup and keep me going because I enjoy connecting with people outside of the dental practice. It was a great teambuilding activity for my team, and I got feedback about how powerful it was for parents and teachers to see the kids interact," he said. "It's a community program that had nothing to do directly with oral health but made people happy, well-connected and more well. When you have better relationships, the best health and oral health follow."

Dr. Holt said he is humbled to receive the Tom Tucker Humanitarian Award and hopes to provide inspiration to other dentists the way Dr. Tucker provided it for him. "He was willing to build bridges and have conversations

with anybody and find common connections with everybody, and when I think about the award, I think about the word 'humanity,'" he said.

"I would encourage dentists to look for the humanity that is right outside your door. We don't have to go very far to find people who need us. There are opportunities every day to touch people's lives, and they can be people in your own neighborhood," Dr. Holt said, adding those opportunities are bigger than dentistry, ranging from volunteering to lead youth sports teams to participating in community health programs. Dr. Holt thanked Noriko, his wife of 27 years, for her support of his professional endeavors. "No one can receive an award like this without having a network of support, and for me that has been my wife. She has made it possible for me to give
